## Reading Text (Literary and Informational)

### Development

Follow a writing process to produce writings in narrative, expository and argumentative genres:

- b Expository (informational/explanatory) writing to examine a topic with relevant facts, examples, and details; establish relationships between ideas and supporting evidence. 7.W.2.A.B
- c Argumentative writing introducing and supporting a claim with clear reasons and relevant evidence, acknowledging counterclaims, and establishing relationships between claims and supporting evidence. 7.W.2.A.C

Revise and edit writing with consideration for task, purpose and audience.
