**Introduction.** **B**

**1** Career and technical education instruction provides content aligned with challenging academic standards and relevant technical knowledge and skills for students to further their education and succeed in current or emerging professions. **B.1**

**2** The Human Services Career Cluster focuses on preparing individuals for employment in career pathways that relate to families and human needs such as counseling and mental health services, family and community services, personal care services, and consumer services. **B.2**

**3** In Barbering I, students coordinate integration of academic, career, and technical knowledge and skills in a laboratory instructional sequence of courses designed to provide job-specific training for employment in barbering careers. Instruction includes sterilization and sanitation procedures, hair care, nail care, and skin care and meets the Texas Department of Licensing and Regulation (TDLR) requirements for licensure upon passing the state examination. Analysis of career opportunities, license requirements, knowledge and skills expectations, and development of workplace skills are included. **B.3**

**4** Students are encouraged to participate in extended learning experiences such as career and technical student organizations and other leadership or extracurricular organizations. **B.4**

- 1 The student demonstrates professional standards/employability skills as required by business and industry. The student is expected to: c.1**
- A demonstrate professionalism in how to dress appropriately, speak politely, and conduct oneself in a manner appropriate for the profession and work site; **c.1.A**
  - B employ the ability to be trustworthy by complying with an ethical course of action; **c.1.B**
  - C comply with all applicable rules, laws, and regulations; **c.1.C**
  - D use conflict-management skills to avoid potential or perceived conflict; **c.1.D**
  - E investigate employment opportunities, including entrepreneurship; **c.1.E**
  - F evaluate data or outcome of a broad range of personal care services; **c.1.F**

  - G explain the principles and practices of infection control, including bacterial disorders and diseases and viruses; and **c.2.G**
  - H explore the nature of electricity by defining types of electric current and the electric modalities used in barbering. **c.2.H**

**3 The student demonstrates knowledge of rules and regulations established by the TDLR. The student is expected to:** C.3

- C navigate the TDLR website for exam eligibility, exam results, and student hours; and C.3.C
- D identify licensure and renewal requirements of the licensee or licensed barbering establishment or school. C.3.D

- D apply universal precautions in disposal of hazardous materials. C.4.D

**5 The student applies the academic knowledge and practical skills to simulated and actual work situations. The student is expected to:** C.5

- A apply client consultation skills to guide individuals in recognizing concerns and making informed decisions; C.5.A
- B document client satisfaction, procedures, and products to facilitate ease of consultation in future appointments; C.5.B
- C Locate and compare vendors to maximize benefits for personal care clients, businesses, or organizations; C.5.C
- D demonstrate understanding and proficiency of basic haircuts such as zero degree, forty-five degree, ninety degree, and one hundred eighty degree; C.5.D
- E perform basic manicure, facial, and mock chemical service application as required for the state practical exam; and C.5.E
- F execute treatment of the scalp, facial massage and treatment, shaving and facial hair design, haircutting and styling, hair replacement, and chemical texture services as required for the state practical exam. C.5.F
